

The temperature returned to 37 (mild tertian) or remained at 38-38.5 on the second day (malignant tertian). But this tertian attack may not be single and in 3 per cent, of our cases it recurred several times, constituting the double or triple or quadruple tertian attack which the 2nd, 4th, 6th and the 8th days are the fever-free days. In another form, the double tertian, which, in my wards, has been more frequent than the tertian, there are three daily attacks without any interval. This happened in 18 per cent, of our cases. This form may be unique or may recur in the form of six daily attacks (.5 per cent, of our cases). On only one occasion have I seen it tripled, nine daily attacks. This is the most depressing form. The patient promptly becomes anaemic, is pallid and invariably loses weight rapidly consequently upon these repeated attacks. In 13 per cent, of our cases these two types of attack, the tertian and double tertian, were associated. A tertian may follow a double tertian and vice versa (5 per cent, of the cases) and the third day of a tertian may possibly be the first of a double tertian. The occurrence of these attacks can be explained by the multiplication in the patients blood of successive generations of merozoites, the apyretic days of one attack impinging on the febrile days of the second generation....
